

WHEREAS the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Thomas Deuster, 1210 Shepherds Path, Green Bay, WI. 54313 Tax Parcel # 6H-2983

WHEREAS, the parcel is described as follows:

Lot Twenty-seven (27), according to the recorded Plat of Desert Winds, said

Plat being part of the Northeast Quarter of the Southwest Quarter (NE% of

SW%) and part of Government Lot Fifteen (15), Section Thirty (30), Township

Twenty-four (24) North, Range Twenty (20) East, in the Fourth Principle

Meridian, in the City of Green Bay, West side of Fox River, Brown County,

the above described parcel is requested in **trust** status to expand Oneida Tribal land base and provide a future site for economic development, housing, recreation, conservancy, and agriculture, and

WHEREAS the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and

NOW, THEREFORE BE IT RESOLVED, that the Oneida Business Committee herebyrequests that the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.
