BC Resolution # 3-05-97-E

*Resolution Adopting the Vendor's Licensing Ordinance*

- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of the Wisconsin, and
- WHEREAS, the General Tribal Council has been delegated the authority of the Constitution of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS, the Oneida Nation desires to create an avenue for revenue generation and further affirmation of sovereign nation status, and
- WHEREAS, the General Tribal Council adopted resolution # GTC 6/30/90-A and addendum, which directs that new revenue sources will be developed to generate funds for the Oneida Per Capita Payment Distribution Trust Plan - Sr. Citizens, and
- WHEREAS, the Oneida Business Committee adopted resolution BC 2-19-92-C in response to that 1990 General Tribal Council Directive, and
- WHEREAS, a Memorandum of Agreement was entered into between the Oneida Business Committee and the Oneida Trust Committee pursuant to Resolution # 2-25-94-B, to transfer authority for enforcing the Oneida Vendor's Licensing Ordinance to the Oneida Compliance Division, and
- WHEREAS, the original ordinance, numbered #2-19-92-C is presently unworkable in the Tribe's present structure, and the Oneida Vendor's Licensing Ordinance, as amended, is workable and practical, and will satisfy the purposes of the original resolution and ordinance, and
- WHEREAS, the Oneida Vendor's Licensing Ordinance, as amended, would fulfill the Business Committee's mandate that the Oneida Tribe implement a collection of Vendors Licensing fees/permits, and
- WHEREAS, the revenue collected as vendor's license fees would have a positive impact on the Tribe's Per Capita Trust Fund, and, as equally distributed, for the administration of the Compliance Division and,


NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby adopts the Oneida Vendor's Licensing Ordinance for implementation on July 1, 1997, for fees due in fiscal year 1998.

BE IT FURTHER RESOLVED, that in the interim period the Compliance Division, or its subordinate entity, shall notify all vendors of the Oneida Tribe of the implementation of this ordinance and make available appropriate applications and,

BE IT FINALLY RESOLVED, that the Licensing Commission, when created, shall develop the equitable fee schedule for adoption by the Oneida Business Committee as required in sec. 6-1(a) of this ordinance. Provided that, in the event the License Committee is not created in a timely manner, the Compliance Division, or a subordinate entity thereof, shall create this initial fee schedule for approval by the Oneida Business Committee.
