## COMMUNITY INJURY CONTROL PROGRAM RESOLUTION NO. 3-9-84-9

WHEREAS, The Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governmental body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Constitution by the Oneida General Tribal Council to protect and preserve the sovereignty of the Oneida Tribe, its rights and its resources, and

WHEREAS, accidents are a leading cause of death of Indian people, and

WHEREAS, the establishment of a Community Injury Control Program will contribute to a reduction in accidents on the Oneida Reservation, and

WHEREAS, the Indian Health Service has made a demonstration program available to the Oneida Tribe.

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee, on behalf of the Oneida General Tribal Council, supports the establishment of a Community Injury Control Demonstration Project on the Oneida Indian Reservation.
