## RESOLUTION # 4-24-96 J REGARDING PARDON OF Michael Redhail

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV., Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council and
- WHEREAS, the Oneida Screening Committee has presented a Pardon Petition on behalf of Michael Redhail, and
- WHEREAS, the requirements of the Oneida Pardon Ordinance and Oneida Pardon Procedures Policy have been fulfilled, and
- WHEREAS, the Oneida Screening Committee hereby recommends  GRANTING  
 DENYING the Pardon Petition of Michael Redhail, Petitioner.


NOW THEREFORE BE IT RESOLVED: That the Oneida Business Committee by this resolution hereby:

GRANTS the Pardon of Michael Redhail, Petitioner and notifies the Oneida Nation and its employing agencies that the Petitioner is recognized as a member of the Oneida Nation to have all the benefits and employment opportunities available to all other persons as if the criminal past pardoned by this Resolution did not exist. This pardon is granted by the signature of all members of the Oneida Business Committee members on the attached Pardon Certificate.

DENIES the Pardon of \_\_\_\_\_, Petitioner and notifies the Petitioner that he/she may request another pardon after one year from the date of certification of this document.

### CERTIFICATION
