WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Dean O'Connell property, 3116 Sandia Dr., Green Bay, WI. 54313

whereas, the parcel is described as follows:
LOT TWELVE (12), ACCORDING TO THE RECORDED PLAT OF THE WESTERN DUNES,
IN THE CITY OF GREEN BAY, WEST SIDE OF FOX RIVER, BROWN COUNTY,
WISCONSIN, SAID PLAT BEING PART OF THE NORTHWEST % OF THE SOUTHWEST
%, SECTION 30, TOWNSHIP 24 NORTH, RANGE 20 EAST OF THE FOURTH
PRINCIPAL MERIDIAN, BROWN COUNTY, WISCONSIN. PARCEL CONTAINS .26
ACRES MORE OR LESS.
