

## RESOLUTION # 5-19-93-B

Resolution regarding Oneida Contract & Hiring preference in Construction of Buildings & Improvements

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the general goal of the Oneida Tribe is to protect, maintain, and improve the standard of living and the environment in which the Oneida people live, while maintaining and enforcing their sovereign rights, and
- WHEREAS, as the Oneida Tribe employs qualified capable members for construction, repair, and maintenance of all housing, proposed housing, and other facilities, and
- WHEREAS, as the construction, plumbing, and electrical contractors of the Oneida Tribe can provide and quarantee quality construction, repair, and maintenance of all housing, proposed housing, and other facilities, and
- WHEREAS, the Oneida Tribe adheres to a policy of Oneida Indian and secondly, Indian Preference for construction hiring and contracting, and
- WHEREAS, the Oneida Tribe further adheres to the Oneida Nation policy of "Oneida and Indian Preference" for all hiring,
- NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe and all it's entities utilize and extend preference in contracts to the Oneida Tribal Construction enterprises, in all construction, including plumbing, electrical, carpentry, renovation, material, supplies, repairs, heavy construction, commercial building, and residential buildings being constructed now and for all future development on the Oneida Reservation, and

- BE IT FURTHER RESOLVED: that the preference in construction hiring and contracting applies to all sub-contractors including those working for the tribal construction enterprise as well as those working for private Oneida firms, partnerships, and individuals, and
- BE IT RESOLVED: that contract preference and hiring applies to all Tribal Departments, Boards, Commissions, authorities, and enterprises, including all independently established organizations, authorities and corporations owned by the Oneida Tribe, and
- BE IT RESOLVED: that the Community Development Division is directed to prepare policies and procedures, including appropriate guidelines governing Oneida Preference in construction and hiring, and
- BE IT FINALLY RESOLVED: that the Community Development Division shall designate a person to be assigned the responsibility of compliance oversight, pending the establishment of a position of Compliance Officer, by the Oneida Business Committee.
- BE IT FINALLY RESOLVED: that Indian Preference will be added to all contracts and sub contracts.

## CERTIFICATION
