## RESOLUTION # 5-26-93-D

RESOLUTION BY THE ONEIDA TRIBE OF INDIANS OF WISCONSIN SUPPORTING THE REQUEST OF HASKELL INDIAN JUNIOR COLLEGE FOR AN INCREASE OF \$7.9 MILLION DOLLARS.

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Haskell Indian Junior College has a long history of providing education to Indian Tribes and Nations across the Country, having been established in 1884 for this purpose; and

WHEREAS, Haskell is a Federally-funded College, one of three intertribal Colleges in the Nation; and

WHEREAS, Haskell has a current enrollment of over 900 students representing 142 Indian Nations and Tribes over 32 States, Thereby making it the Largest attended Indian Nations College in the Country; and

WHEREAS, With the critical need for Indian teachers throughout the Country, Haskell met the challenge by offering a Teacher Training program to begin in the fall of 1993; and

WHEREAS, Haskell offers other programs that attempt to meet the needs of Indian Tribes and Nations and will continue to meet the challenges it is presented by Tribes and Nations; and

WHEREAS, It is for this reason that the additional program proposed is an expansion beyond other programs already offered;

NOW THEREFORE BE IT RESOLVED: that an increase of \$7.9 Million dollars be awarded to the Haskell Educational System in the Fiscal Year Budget for 1994 in order to provide a quality teacher training program for Indians across the Country.
