## RESOLUTION # 6-12-96-F

- WHEREAS,** The Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and Treaty Tribe recognized by the laws of the United States, and
- WHEREAS,** The Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** The Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** The State of Wisconsin, Department of Transportation, has made application for a Permanent Limited Easement over Oneida tribal property in order to make road improvements on Highway 54, and
- WHEREAS,** The request for Permanent Limited Easement involves the following parcel of Oneida Tribal Land:

ALL THAT LAND OF GRANTOR IN THE NE $\frac{1}{4}$ -SE $\frac{1}{4}$  AND LOT 9 OF SECTION 25, T24N, R19E, CITY OF GREEN BAY AND TOWN OF HOBART, BROWN COUNTY, WISCONSIN, LYING WITHIN THE FOLLOWING DESCRIBED TRAVERSE:

BEGINNING AT THE NORTHEAST CORNER OF THE NE $\frac{1}{4}$ -SE $\frac{1}{4}$  OF SAID SECTION 25; THENCE S 01°10'22"E ALONG THE EAST LINE OF SAID NE $\frac{1}{4}$ -SE $\frac{1}{4}$  FOR 277.34 FEET TO THE STH 54 REFERENCE LINE AND ON A CURVE WITH A RADIUS OF 1432.69 FEET AND A LONG CHORD BEARING S 51°47'48"W, 25.00 FEET; THENCE SOUTHWESTERLY ALONG SAID REFERENCE LINE AND CURVE TO THE LEFT 25.00 FEET; THENCE CONTINUING ALONG SAID REFERENCE LINE S 51°17'48" W FOR 341.15 FEET; THENCE N 27°44'08"E FOR 125.08 FEET TO THE PROPOSED NORTHWESTERLY RIGHT-OF-WAY LINE OF STH 54; THENCE N 27°44'08"E ALONG SAID LINE FOR 237.66 FEET TO A CURVE WITH A RADIUS OF 326.48 FEET AND A LONG CHORD BEARING OF N 05°46'46"E, 188.37 FEET; THENCE NORTHERLY ALONG SAID CURVE TO THE RIGHT FOR 191.09 FEET; THENCE N 22°32'47"E FOR 20.00 FEET TO A CURVE WITH A RADIUS OF 531.27 FEET AND A LONG CHORD BEARING N 10°43'34"E, 217.65 FEET; THENCE NORTHERLY ALONG SAID CURVE TO THE LEFT 219.21 FEET TO THE EXISTING WESTERLY RIGHT-OF-WAY LINE OF HILLCREST DRIVE; THENCE N 88°32'59"E FOR 38.28 FEET TO THE EAST LINE OF SAID LOT 9; THENCE S 01°27'01"E ALONG SAID EAST LINE FOR 235.79 FEET TO THE POINT OF BEGINNING. SAID PARCEL CONTAINS 0.65 ACRE, MORE OR LESS. ALSO INCLUDED HEREIN IS 0.33 ACRE, MORE OR LESS, LYING WITHIN THE EXISTING RIGHT-OF-WAY.

and

- WHEREAS,** The length of term for the Permanent Limited Easement shall be permanent from the date of approval,

and

**WHEREAS,** the State of Wisconsin, Department of Transportation, has also made application for Temporary Limited Easements for sloping on that land of the Tribe in the NE¼-SE¼ and Lot 9 of Section 25, T24N, R19E: one being a 25 foot wide strip lying adjacent to and parallel to the STH 54 right-of-way line; one being triangular shaped and lying west of and adjacent to the proposed right-of-way line described above, including for such purposes the right to operate necessary equipment thereon, the right of ingress and egress, and the right to preserve protect, remove or plant any vegetation thereon until completion of the Highway 54 construction project, and

**WHEREAS,** The State of Wisconsin and the Oneida Tribe have negotiated the amount of compensation and damages for the above-mentioned easements and have agreed it shall be Six Thousand Dollars and No Cents (\$6,000.00).


**NOW THEREFORE BE IT RESOLVED** that the Oneida Tribe of Indians of Wisconsin hereby grants to the State of Wisconsin, Department of Transportation, a Permanent Limited Easement over the above-described property for the purpose of making road improvements to Highway 54, and

**BE IT FURTHER RESOLVED** that the Oneida Tribe of Indians of Wisconsin hereby grants to the State of Wisconsin, Department of Transportation, the requested Temporary Limited Easements for the purposes enumerated above, and

**BE IT FINALLY RESOLVED** that the Chairperson of the Oneida Business Committee is hereby authorized to execute the attached Permanent Limited Easement, for and on the behalf of the Oneida Tribe of Indians of Wisconsin, said document containing both of the above-described grants of easements.

#### CERTIFICATION

I, the undersigned, as Secretary of the Oneida Business Committee, hereby certify that the Oneida Business Committee is composed of 9 members of whom 5 members constitute a quorum, 9 members were present at a meeting duly called, noticed and held on the 12th day of June, 1996; that the foregoing resolution was duly adopted at such meeting by a vote of 8 members for; 0 members against, and 0 members not voting; and that said resolution has not been rescinded or amended in any way.
