BRUNETTE</u> Petitioner and notifies the Oneida Nation and its employing agencies that the Petitioner is recognized as a member of the Oneida Nation to have all the benefits and employment opportunities available to all other persons as if the criminal past pardoned by this Resolution did not exist. This pardon is granted by the signature of all members of the Oneida Business Committee members on the attached Pardon Certificate.

_____DENIES the Pardon of Petitioner and notifies the Petitioner that he/she may request another pardon after one year from the date of certification of this document.
