This pardon is granted by the signature of all members of the Oneida Business Committee members on the attached Pardon Certificate.

\_\_\_\_\_DENIES the Pardon of \_\_\_\_\_\_Petitioner and notifies the Petitioner that he/she may request another pardon after one year from the date of certification of this document.
