## RESOLUTION # 7-05-95-B

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Business Committee has approved a procurement sign-off procedure that adequately protects the security of the process of entering into contracts, and

WHEREAS, through implementation there has been found to be difficulties posed by the current approval process in the Independent Contractor's Policy adopted by the Oneida Business Committee in 1994, and

WHEREAS, the process for modifying the existing policy is ongoing and likely to take additional time,

WHEREAS, there continues to be review and revisions to the policy to this date and the need to have the amended procedures remain in place for an additional six months continues,

NOW THEREFORE BE IT RESOLVED: that Article VII of the existing policy continue to be affected by the emergency amendments for an additional six months as allowed under the authority delegated in the Emergency Amendments of the Oneida Administrative Procedures Act, and that these amendments shall be effective for six months following adoption.


NOW THEREFORE BE IT FURTHER RESOLVED: that conflict sections within the pre-existing policy continue to be resolved in favor of the amendments regarding approval process and notification processes.

NOW THEREFORE BE IT FURTHER RESOLVED: that the Oneida Legislative Operating Committee is hereby directed to complete the revisions of the Independent Contracting Policy within six months

NOW THEREFORE BE IT FINALLY RESOLVED: that all the General Manager and all Division Directors are directed to continue to submit position papers to any and all Public Hearings which may be scheduled for the proposed revisions within the time lines directed by the Administrative Procedures Act. The position paper to include any effect, whether negative or positive, the proposed policy may have on the entities within the Division. The General Manager to bring forth a position paper if desired on the overall effect of the proposed policy on Tribal entities.

#### CERTIFICATION
