
RESOLUTION # 7-05-95-6

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS the Oneida Tribe has acquired in fee status the following parcel described as: Robert Calaway Property, Tax Parcel No. 17-0-1114-01
- WHEREAS, the parcel is described as follows:  
Part of the Southwest Quarter of the Southeast Quarter of Section 23, Township 23 North, Range 18 East, Town of Oneida, Outagamie County, Wisconsin, described as follows: The South 208 feet of the West 208 feet of the East 1058 feet thereof, less and excepting premises conveyed for highway purposes and recorded in Volume 398 of Deeds, Page 272, in Jacket 6198, Image 16; and in Jacket 6198, Image 18.
- WHEREAS, the above described parcel is requested in trust status to expand Oneida Tribal land base and provide a future site for economic development, housing, recreation, conservancy, and agriculture, and
- WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and

NOW, THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.
