

## RESOLUTION # 8-4-93-C

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribal Sanitary District Ordinance authorizes the Oneida Utilities Commission to issue tax exempt revenue bonds for the financing and construction of sewer and water projects, and
- WHEREAS, the Oneida Tribe of Indians of Wisconsin and the Oneida Utilities Commission desires to amend the Oneida Tribal Sanitary District Ordinance to allow the Oneida Utilities Commission to issue tax exempt revenue bonds for purposes other than sewer and water projects, and
- WHEREAS, the amendments will provide authority for and to empower the Oneida Utilities Commission to undertake, on behalf and а duly constituted authority instrumentality Tribe, of the the acquisition. construction, equipping, improvement and financing of public governmental facilities and improvements by the issuing of tax exempt revenue bonds for the Oneida Tribe with the approval of the Business Committee.
- NOW THEREFORE BE IT RESOLVED that the Oneida Business Committee, in session assembled, hereby approves and adopts the amendments to the Oneida Tribal Sanitary District Ordinance to allow the Oneida Utilities Commission to issue tax exempt revenue bonds for purposes other than sewer and water projects, such amendments attached hereto
