## RESOLUTION #\_08-20-97R Louis and Amy Williams Residential Lease

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a Federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Louis J. Williams, #6528 and Amy L.F. Williams, non-Oneida, a/are Tribal Member(s), have made application for a long-term lease for residential purposes; and

WHEREAS, Louis J. Williams, #6528 and Amy L.F. Williams, non-Oneida, has/have been designated Lease No. RL 2868(97) for the Tribal land selected and is more particularly described as follows: 1210 Sheperds Path, Green Bay, WI 54313.

Lot Twenty-seven (27), according to the recorded Plat of Desert Winds, said Plat being part of the Northeast Quarter of the Southwest Quarter (NE 1/4 of SW 1/4) and part of Government Lot Fifteen (15), Section Thirty (30), Township Twenty four (24) North, Range Twenty (20) East, in the Fourth Principle Meridian, in the City of Green Bay, West side of Fox River, Brown County, Wisconsin.

WHEREAS, the Oneida Tribe of Indians of Wisconsin's Division of Land Management is responsible for managing all tribal real property assets, including leases, through rules and policies approved in Oneida Real Property Law; and

NOW, THEREFORE, BE IT RESOLVED by this Committee in Regular assembled, hereby requests the Superintendent, Great Lakes Agency, to draft a lease in accordance with the Act of August 9, 1955 (69 Stat, 539), as amended, 25 USC 415, for the above-described land with a 25 year term which shall automatically and without notice renew for an additional term of 25 years at a total rental, half fare rental rate to be determined by an appraisal, and

BE IT FURTHER RESOLVED that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease documents for and on behalf of the Oneida Tribe.

BE IT FURTHER RESOLVED that Christine M. Doxtator, Land Management Director, or her designee, be authorized to execute said lease agreement on behalf of the Oneida Tribe.
