the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS

the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS,

the Oneida Tribe has acquired in fee status the following parcel described as: Lloyd A. & Marie L. Buck, 4944 County Line Road, Oneida, WI. 54155, Tax Parcel No.:HB-496

WHEREAS

the parcel is described as follows:
