## RESOLUTION # 8-23-95-K

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Neil & Darlene Mishleau, Tax Parcel No.: 17-0-2036-00

WHEREAS, the parcel is described as follows:  
Commencing at the East  $\frac{1}{4}$  Corner of said Section 19; Thence S 89 $\text{p}$ 26'29"W, 674.23 feet to the point of beginning; Thence continuing S 89 $\text{p}$ 26'29", 66.00 feet; Thence N 00 $\text{p}$ 00'00"E, 263.38 feet; Thence N 51 $\text{p}$ 12'00"W, 199.83 feet; Thence S 26 $\text{p}$ 46'18"W, 142.65 feet; Thence S 89 $\text{p}$ 28'29"W, 176.52 feet; Thence N 26 $\text{p}$ 13'09"E, 367.02 feet; Thence S 89 $\text{p}$ 26'29"W, 604.62 feet; Thence N 00 $\text{p}$ 00'00"E, 320.00 feet; Thence N 90 $\text{p}$ 00'00"E, 494.23 feet; Thence S 41 $\text{p}$ 58'19"E, 384.37 feet; Thence along the arc of a curve to the right 152.85 feet (chord bearing S 59 $\text{p}$ 05'24"E, 114.75 feet); Thence S 13 $\text{p}$ 53'31"W, 178.33 feet; Thence along the arc of a curve to the left 16.24 feet (chord bearing S 06 $\text{p}$ 56'4"W, 16.21 feet); Thence along the arc of a curve to the left 16.24 feet (chord bearing S 06 $\text{p}$ 56'46"W, 16.21 feet); Thence S 00 $\text{p}$ 00'00"W, 369.29 feet to the point of beginning.


