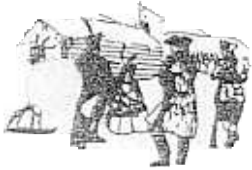

## BC Resolution # 09-17-97E *Resolution Adopting the Oneida Room Tax Law*

WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of the Wisconsin, and

WHEREAS, the General Tribal Council has been delegated the authority of the Constitution of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and

WHEREAS, the Oneida Business Committee adopted the Oneida Room Tax Law by emergency action, by adopting resolution # BC-4-2-97-B, to begin collecting a total tax of 8% from hotels, motels and other like operations within the jurisdiction of the Oneida Tribe, and

WHEREAS, the Legislative Operating Committee has conducted the appropriate Public Hearings and reviewed the comments made at that Public Hearing, and

WHEREAS, the Oneida Room Tax Law to be implemented will collect an 8% tax on all rooms rented to transients within the Oneida Reservation via collection by the hotel or other similar operation,

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby adopts the attached Oneida Room Tax Law for immediate implementation, and

NOW THEREFORE BE IT FURTHER RESOLVED, that until otherwise identified, the Chief Financial Officer shall designate a Tax Collector as defined within the attached Oneida Room Tax Law, and

NOW THEREFORE BE IT FURTHER RESOLVED, that the Oneida Tribe shall designate an account which shall maintain any funds collected under this law for special use purposes, and

NOW THEREFORE BE IT FINALLY RESOLVED, that until otherwise identified within the Oneida Room Tax Law, special purposes shall be identified as the "Convention Center Project."
