RESOLUTION # 9-21-94 H

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, The Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, John A. and Stacey B. Doxtater, both tribal member, residing at 565 Silas Drive, DePere, WI 54115, have submitted an application for a long-term lease for residential purposes; and

WHEREAS, the tribal land selection is described as follows:

A parcel of land located in the SW 1/4 SW 1/4, Section 11, Township 23 North, Range 19 East, 4th P.M., Brown County, Wisconsin, more particularly described as: Commencing at the NW corner of the SW 1/4SW 1/4; thence S89°48'45"E, 885.00 feet; thence S0°22'43"W, 330.00 feet to the Point of Beginning; thence S0°22'43"W, 24.75 feet; thence N89°37'17"W, 49.00 feet; thence S0°22'43"W, 353.41 feet; thence N89°42'30"E, 211.78 feet; thence N0°38'39"E, 376.25 feet; thence N89°48'45"W, 164.49 feet, to the Point of Beginning, containing 1.81 acres, more or less. The lease shall include authorization for lessee to utilize existing road for ingress and egress.

WHEREAS, the lease will be for a term of 25 years, with an automatic renewal for 25 years, with an annual rent of \$1.00 due annually, on the anniversary of the date of approval, or \$50 for fifty years.

NOW, THEREFORE BE IT RESOLVED, by this Committee in Regular session assembled, that the lease is hereby approved and request the Superintendent, Great Lakes Agency, to prepare and approve the lease in accordance with applicable regulations; and

BE IT FURTHER RESOLVED, that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease documents for and on behalf of the Oneida Tribe of Indians of Wisconsin.
