Lyle Hill Resolution

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a Federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Lyle Hill, #2415, a/are Tribal Member(s), have made application for a long-term lease for residential purposes; and

WHEREAS, Lyle Hill, #2415, has/have been designated Lease No. RL-2906(97) for the Tribal land selected and is more particularly described as follows: 2884 Commissioner Street, Oneida WI 54155.

A parcel of land located within Claim 141, Section 3, T. 23N.,R.19E., more particularly described as: Commencing at the NE corner of said Claim 141 where it intersects with CTH "E"; thence N.60 degrees 51'W., a distance of 621.70 feet; thence S.29 degrees 55'W., a distance of 394.70 feet to the Point of Beginning; thence N.60 degrees 05'W., a distance of 130 feet; thence S. 29 degrees 55'W., a distance of 90 feet; thence S. 60 degrees 05'E., a distance of 130 feet; thence N.29 degrees 55'E., a distance of 90 feet, more or less, to the Point of Beginning, containing .27 acres, more or less, subject to all valid existing rights-of-way of record.

WHEREAS, the Oneida Tribe of Indians of Wisconsin's Division of Land Management is responsible for managing all tribal real property assets, including leases, through rules and policies approved in Oneida Real Property Law; and

NOW, THEREFORE, BE IT RESOLVED by this Committee in <u>Regular</u> assembled, hereby requests the Superintendent, Great Lakes Agency, to draft a lease in accordance with the Act of August 9, 1955 (69 Stat, 539), as amended, 25 USC 415, for the above-described land with a 25 year term which shall automatically and without notice renew for an additional term of 25 years at a total rental, \$1.00 per year or \$50 for fifty years, at a total rental to be determined by an appraisal, and

BE IT FURTHER RESOLVED that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease documents for and on behalf of the Oneida Tribe.

BE IT FURTHER RESOLVED that Christine M. Doxtator, Land Management Director, or her designee, be authorized to execute said lease agreement on behalf of the Oneida Tribe.
