Robert and Charlene Sanders Resolution

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a Federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Charlene M. #4557 and Robert L. #non-Oneida, Sanders, a/are Tribal Member(s), have made application for a long-term lease for residential purposes; and

WHEREAS, Charlene M. #4557 and Robert L. #non-Oneida, Sanders, has/have been designated Lease No. RL-2836 (97) for the Tribal land selected and is more particularly described as follows: 1050 Pleasant Lane, Green Bay, Wisconsin 54313.

Parcel B: Part of the Northwest 1/4-Southeast 1/4, Section 25, T24N-R21E, City of Green Bay, Brown County, Wisconsin, Fourth Principal Meridian, more fully described as follows: Commencing at the monumented center of Section 25, T24N-R21E; thence S89 degrees 27'52"E, 1317.27 feet along the north line of the Southeast 1/4, said Section 25, to the centerline of Pleasant Lane; thence SO degrees 04'52"W, 177.50 feet aldong said centerline to the point of beginning; thence continuing SO degrees 04'52"W, 290.50 feet along said centerline; thence N89 degrees 27'52"W, 300.00 feet; thence No degrees 04'52"E, 290.50 feet; thence S89 degrees 27'52"E, 333.00 feet to the centerline of Pleasant Lane and the point of beginning. Parcel contains 87,148 square feet/2.00 acres, more or less, to 33 foot road right-of-way. Parcel contains 96,733 square feet/2.22 acres, more or less, to section line.

WHEREAS, the Oneida Tribe of Indians of Wisconsin's Division of Land Management is responsible for managing all tribal real property assets, including leases, through rules and policies approved in Oneida Real Property Law; and

NOW, THEREFORE, BE IT RESOLVED by this Committee in <u>Regular</u> assembled, hereby requests the Superintendent, Great Lakes Agency, to draft a lease in accordance with the Act of August 9, 1955 (69 Stat, 539), as amended, 25 USC 415, for the above-described land with a 25 year term which shall automatically and without notice renew for an additional term of 25 years at a total rental, half-fare rental rate to be determined by an appraisal, and

BE IT FURTHER RESOLVED that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease documents for and on behalf of the Oneida Tribe.

BE IT FURTHER RESOLVED that Christine M. Doxtator, Land Management Director, or her designee, be authorized to execute said lease agreement on behalf of the Oneida Tribe.
