

WHEREAS

the Oneida Tribe of Indians of Wisconsin is a federally reconized Indian Government and a Treaty Tribe reconized by the laws of the United States, and

WHEREAS.

the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS

the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS

the Oneida Tribe has acquired in fee status the following parcel described as: Steven D. & Lynn A. Livermore, 3032 Ferndale Drive, Green Bay, WI. Tax Parcel # 6H-2734

WHEREAS,

the parcel is described as follows:

Lot Twenty-four (24), according to the recorded Plat of The Dunes, said plat being a part of Lots Sixteen (16) and Seventeen (17), Section Thirty (30), Township Twenty-four (24) North, Range Twenty (20) East, in the Fourth Principal Meridian, in the City of Green Bay, West side of Fox River, Brown County, Wisconsin.

WHEREAS,

the above described parcel is requested in trust status to expand Oneida Tribal land base and provide a future site for economic development, housing, recreation, conservancy, and agriculture, and

WHEREAS,

the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and
