RESOLUTION # 10-30-96-F

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a Federally recognized Indian government and Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Judith Jordan, #8997, a Tribal Member, have made application for a long-term lease for residential purposes; and

WHEREAS, Judith Jordan, #8997, has been designated Lease No. RL-2788(96) for the tribal land selected and is more particularly described as follows:


Parcel B and the South Twenty (20) feet of Parcel C of Vol. 1 Certified Survey Maps, page 39, and map being a part of Government Lot B of Section Thirty-two (32) Township Twenty-four (24) North Range Twenty (20) East, in the City of Green Bay, West Side of Fox River, Brown County, Wisconsin. Tax Parcel No. H-1264-2-2. Mailing address 2442 Oakwood Drive, Green Bay, Wi.

NOW, THEREFORE, BE IT RESOLVED by this Committee in Regular session assembled, hereby requests the Superintendent, Great Lakes Agency, to draft a lease in accordance with the he Act of August 9, 1955 (69 Stat, 539), as amended, 25 USC 415, for the above-described land with a 25 year term which shall automatically and without notice renew for an additional them of 25 years at a total rental, \$1.00 per year or \$50 for fifty years, and

BE IT FURTHER RESOLVED that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease documents for and on behalf of the Oneida Tribe.
