- WHEREAS, The Oneida Tribe has leased tribal lands located in Claim #68, Section 17, Township 23 North, Range 19 East, Outagamie County, Wis., to the Oneida Housing Authority;
- WHEREAS, The Oneida Housing Authority wishes to turn the Joshua Court Road over to the Township of Oneida for maintenance, and the Township of Oneida has agreed to accept this road for maintenance by easement. An easement is required to enter the Joshua Court Road into the Township road system, making it eligible for gas tax aids; and
- WHEREAS, the description of this road, known as Joshua Court Road, is described on the attachment to this resolution; and
- WHEREAS, the easement will be granted in perpetuity for the express purpose of maintenance, snowplowing, etc.
- NOW, THEREFORE, BE IT RESOLVED that this Committee in <u>SPECIA</u> session assembled, hereby approves an easement in perpetuity for the Joshua Court Road to the Township of Oneida, and requests the Superintendent, Great Lakes Agency, to prepare and recommend approval of the easement.
- BE IT FURTHER RESOLVED that the Chairman and Secretary are hereby authorized to execute the easement documents for and on behalf of the Oneida Tribe.
