## RESOLUTION # 11-08-95-D

**WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and

**WHEREAS,** the Oneida General Tribal Council is the governmental body of the Oneida Tribe of Indians of Wisconsin, and

**WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

**WHEREAS,** the goal of the Oneida Tribe is to protect, maintain, and promote self-sufficiency and self reliance by providing housing for those Oneida Tribal members who cannot afford it, and

**WHEREAS,** the Oneida Tribe through the Oneida Community Development Program with the help of the Community Development Block Program for Indian Tribes, and Oneida Community input, would like to expand the supply of affordable housing, and


**WHEREAS,** the Oneida Tribe believes that the Oneida Family will be strengthened by promoting the values of our Oneida Identity by providing housing.

**NOW, THEREFORE, BE IT RESOLVED:** That the Oneida Tribe of Indians of Wisconsin-Oneida Community Development Program authorizes and submits this grant application to the Department of Housing and Urban Development-Community Development Block Grant Program for the purpose of securing affordable, well built housing for those who cannot financially provide it for themselves. Leveraged funds will be committed from the Housing Department.

**NOW, THEREFORE BE IT FURTHER RESOLVED THAT: The Oneida Community is aware of the ongoing funding with adequate information concerning the amount of funds available for proposed community development and housing activities, the range of activities that may be assisted, and other important program requirements, and solicited their view and participation and furthermore, developed and published or posed a community development statement in such a manner as to afford affected residents and opportunity to examine its contents and to submit comments.**
