

RESOLUTION # 11-16-95-19

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government, and a treaty tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe of Indians of Wisconsin is one of three successor communities to the original Oneida Nation, and
- WHEREAS, these three communities (the "Oneida Nation") established their right to territory in the State of New York in two Supreme Court decisions, Oneida Indian Nation v. County of Oneida, 414 U.S. 661 (1974) and County of Oneida v. Oneida Indian Nation, 470 U.S. 226 (1985), and
- WHEREAS, settlement negotiations between the State of New York and the Oneida Nation are finally beginning ten years after the Supreme Court ruled that the Oneida Nation was able to sue for the recovery of title to lands conveyed in violation of the Non-Intercourse Act, and
- WHEREAS, the Oneida Tribe of Indians of Wisconsin is hopeful that these negotiations will result in a settlement acceptable by both the Nation and the State of New York, and
- WHEREAS, the Oneida Tribe of Indians of Wisconsin needs to be prepared for legal challenges to its participation in the settlement negotiations and in any additional proceedings made necessary by the failure of said negotiations, and

- WHEREAS, the failure of said negotiations will also cause the Oneida Tribe of Indians of Wisconsin to incur substantial costs in order to initiate new legal action, and
- WHEREAS, the Oneida Tribe of Indians of Wisconsin wishes to seek the assistance of the Bureau of Indian Affairs with the costs of legal research and the possible costs of initiating new legal action against the current occupants of the claim area,

NOW THEREFORE LET IT BE RESOLVED that the Oneida Tribe of Indians of Wisconsin hereby declares its intention to seek litigation support funds from the Bureau of Indian Affairs in the amount of \$35,000.00 for the purpose of assisting in the research of legal issues relating to its land claims, and to defray the expense of new legal action in the event that current settlement negotiations between the Oneida Tribe of Indians of Wisconsin, the other Oneida communities, and the State of New York prove unsuccessful.
