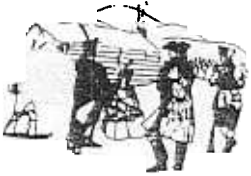

RESOLUTION # 11-26-97-G Artley and Inez Skenandore Residential Lease

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a Federally recognized Indian government and Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Artley Skenandore, #4921 and Inez Skenandore, #5945, a/are Tribal Member(s), have made application for a long-term lease for residential purposes; and

WHEREAS, Artley Skenandore, #4921 and Inez Skenandore, #5945, has/have been designated Lease No. RL-2838(97) for the Tribal land selected and is more particularly described as follows: W624 Cooper Road, Oneida WI 54155.

A parcel of land located in part of Government Lot 17, of the Southwest one-quarter of the Northeast one-quarter of section 20, Township 24 North, Range 19 East, Town of Oneida, Outagamie County, Wisconsin, described as follows:

Commencing at the center one-quarter corner of said Section 20; thence N89 degrees - 43' -06" E along the East West One-Quarter line 922.66 feet to the point of beginning; thence continuing N 89 degrees -43' -06"E 100.00 feet; thence N 0 degrees -04' -54" W 646.83 feet; thence S 89 degrees -43' -06" W 200.00 feet; thence S 0 degrees -04' -54" E 382.83 feet thence N 89 degrees -43' -06" E 100.00 feet; thence S 0 degrees -04' -54" E 264.00 feet to the point of beginning and containing 102,965 square feet, more or less and subject to easements and reservations of record. Said described parcel includes the Southerly 41.25 feet now being used for highway purposes.

WHEREAS, the Oneida Tribe of Indians of Wisconsin's Division of Land Management is responsible for managing all tribal real property assets, including leases, through rules and policies approved in Oneida Real Property Law; and


NOW, THEREFORE, BE IT RESOLVED by this Committee in Regular assembled, hereby requests the Superintendent, Great Lakes Agency, to draft a lease in accordance with the Act of August 9, 1955 (69 Stat, 539), as amended, 25 USC 415, for the above-described land with a 25 year term which shall automatically and without notice renew for an additional term of 25 years at a total rental, \$1.00 per year or \$50 for fifty years, at a total rental to be determined by an appraisal, and

BE IT FURTHER RESOLVED that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease documents for and on behalf of the Oneida Tribe.

BE IT FURTHER RESOLVED that Christine M. Doxtator, Land Management Director, or her designee, be authorized to execute said lease agreement on behalf of the Oneida Tribe.
