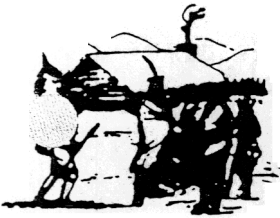

## RESOLUTION # 11-29-95-C

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, Lora a tribal member and Theodore Waupekenay, a non-tribal member, have made application for a long-term lease for residential purposes; and
- WHEREAS, the tribal land selected is described as follows:

Parcel A: Part of the SE $\frac{1}{4}$ SE $\frac{1}{4}$ , Section 11, T24N-R19E, Town of Hobart, Brown County, Wisconsin, more fully described as follows:

Commencing at the southeast corner, Section 11, T24N-R19E; thence N0°00'00"W, 1322.44 feet to the northeast corner of SE $\frac{1}{4}$ SE $\frac{1}{4}$ , said Section 11; thence S85°13'53"W, 982.76 feet along the north line of said SE $\frac{1}{4}$ SW $\frac{1}{4}$ , also being the centerline of Sunlite Drive, to the point of beginning; thence S0°44'44"E, 270.72 feet along the west line of the recorded plat of Clear View Subdivision 3rd Addition; thence S86°38'28"W, 253.13 feet; thence N4°14'25"W, 263.84 feet of the north line of the SE $\frac{1}{4}$ SE $\frac{1}{4}$ , Section 11, T24N-R19E; thence N85°13'53"E, 269.61 feet along said north line, also being the centerline of Sunlite Drive, to the point of beginning.


Parcel contains 69,794 square feet/1.60 acres, more or less, to center line of Sunlite Drive.

Parcel contains 63,140 square feet/1.45 acres, more or less, to 24.75 foot right-of-way of Sunlite Drive.
