

RESOLUTION # <u>11-29-95-K</u>

WHEREAS.

the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and Treaty Tribe recognized by the laws of the United States, and

WHEREAS,

the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS,

the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS,

Debra S. Cornelius, tribal member, has made application for a long-term lease for residential purposes; and

WHEREAS.

the tribal land selected is described as follows:

Commencing at the SE corner of the NE¼NE¼ Section 13, Township 23 North, Range 18 East; thence North, 145.50 feet to the Point of Beginning; thence West, a distance of 330 feet; thence South, a distance of 132 feet; thence East, a distance of 330 feet; thence North, a distance of 132 feet, more or less, to the Point of Beginning, containing 1.00 acres, more or less, subject to all valid existing rights-of-way of record.

NOW, THEREFORE, BE IT RESOLVED by this Committee in Regular session assembled, hereby requests the Superintendent, Great Lakes Agency, to draft a lease in accordance with the he Act of August 9, 1955 (69 Stat. 539), as amended, 25 USC 415, for the above-described land with a 25 year term which shall automatically and without notice renew for an additional them of 25 years at a total rental \$1.00 annually, or \$50.00 for fifty years, and

BE IT FURTHER RESOLVED that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease documents for and on behalf of the Oneida Tribe.
