

WHEREAS, The Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, David and Marie Smith, both tribal members holder of lease no. RL-2158(90) described as follows:

A parcel of land located within Claim 147, Section 3, T 23 N., R 19 E., more particularly described as: Commencing at the SE corner of said Claim 147 where it intersects with CTH "E"; thence N 60 degrees W., a distance of 621.70 feet; thence N 29 degrees East., a distance of 10.30 feet to the Point of beginning; thence N 60 degrees 05' West, a distance of 130 feet; thence N 29 degrees 55' East., a distance of 81 feet; thence S 60 degrees 05'E., a distance of 130 feet; thence S 29 degrees 55' W., a distance of 81 feet, more or less, to the Point of Beginning, containing .24 acres, more or less, subject to all valid existing rights-of-way of record.

WHEREAS, David and Marie Smith, both tribal members holder of lease no RL-2158(90) no longer intends to use said lease site.

NOW, THEREFORE BE IT RESOLVED, that the Oneida Business Committee in Resolved, hereby approves the \*CANCELLATION of lease no. RL-2158(90)

BE IT FURTHER RESOLVED, that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease \*CANCELLATION documents for and in behalf of the Oneida Tribe of Indians of Wisconsin.
