- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as:
Former Frank M. Hock and Patricia A. Hock Property
- WHEREAS, the parcel is described as follows:
Legal Description: See attached.
Tax Parcel Number: HB-543-3
- WHEREAS, the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide an existing residential land use, and
- WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement,

NOW THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.

Commencing at the Southeast corner of Section 11 T24N, R19E; thence N 00°00'00" E, 1322.44 feet to the Northeast corner of the Southeast ¼ of the Southeast ¼ of said Section; thence S 85°13'53" W, 982.76 feet along the North line of said Southeast ¼ of the Southeast ¼ to the point of beginning; thence S 00°44'44" E, 653.17 feet along the Westerly right-of-way line of a future town road; thence S 85°13'53" W, 347.47 feet to the Westerly line of said Southeast ¼ of the Southeast ¼; thence N 00°44'44" W, 653.17 feet along the said West line to the Northwest corner of the Southeast ¼ of the Southeast ¼; thence N 85°13'53" E, 347.47 feet along the North line of the Southeast ¼ of the Southeast ¼ to the point of beginning, excepting therefrom any lands previously conveyed for road purposes.
