
RESOLUTION NO. 4-26-06-H

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as:
Former Kenneth K. Schuyler Property
- WHEREAS, the parcel is described as follows:
Legal Description: See attached.
Tax Parcel Number: HB-1309-2
- WHEREAS, the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide an existing vacant land use and will not be used for gaming purposes, and
- WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement,

NOW THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.

That part of Indian Claim One Hundred Forty-seven (147) beginning at a point on the North line of Indian Claim 147 that is North 60 deg. West 264.5 feet from the intersection of said North line of Indian Claim 147 with the Northerly right of way line of Highway 54, said point being the Northwesterly corner of the parcel of land described in Vol. 293 Deeds, page 545, Brown County Records; thence North 60 deg. West along the North boundary of Indian Claim 147, 120 feet; thence South 30 deg. West approximately 185 feet, more or less, to the Northerly right of way line of Highway 54; thence Northeasterly along said Northerly right of way line to a point that is South 30 deg. West 185 feet from the POINT OF BEGINNING; said point being the Southwesterly corner of the parcel of land described in Vol. 293 Deeds, page 545, Brown County Records; thence North 30 deg. East 185 feet to the point of beginning, EXCEPTING THEREFROM that part thereof being used for road purposes, in the Fourth Principal Meridian, in the Town of Hobart, Brown County, Wisconsin, being the premises described in Vol. 349 Deeds, page 423, Brown County Records.

ALSO DESCRIBED AS:

Part of Indian Claim No. 147, Section 3, T23N - R19E of the Fourth Principal Meridian, Town of Hobart, Brown County, Wisconsin, more fully describe as follows:

Commencing at a 2" Iron pipe located at the intersection of a meander line and the North line of Indian Claim No. 147; thence S59°08'36"E, 124.57 along the North line of said Indian Claim No. 147 to a point on a Easterly line of Jacket 16976 Image 30, Brown County Records said point also being the point of Beginning; thence S59°02'41"E, 120.10' along a South line of said Jacket and Image; thence S30°59'55"W, 185.15' to the North R/W of West Mason Street A/K/A S.T.H. "54"; thence 121.21' along said North R/W being the arc of a 768.72' radius curve to the right whose long chord bears N66°17'34"W, 121.08'; thence N30°59'55"E, 200.41' along a East line of said Jacket and Image to the point of beginning. Parcel contains 23,347 Square Feet, 0.54 Acres
