- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as:  
Former Shirley A. De Pas, as Personal Representative of the estate of Henry P. Smis Property
- WHEREAS, the parcel is described as follows:  
Legal Description: See attached.  
Tax Parcel Numbers: HB-1343, HB-1349, HB-1350, HB-1356
- WHEREAS, the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide a vacant land and will not be used for gaming purposes, and
- WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement,

NOW THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.

A parcel of land located in part of Indian Claim 164, in part of Indian Claim 159 and in part of Indian Claim 156, being in part of Section 34 and Section 35, Township 24 North, Range 19 East of the Fourth Principal Meridian, and being in part of Section 2 and Section 3, Township 23 North, Range 19 East of the Fourth Principal Meridian, in the Town of Hobart, Brown County, Wisconsin.

Commencing at an existing Brown County Monument marking the Northeast corner of Indian Claim 164 and also marking the common corner for Indian Claim 163, Indian Claim 164 and Indian Claim 161 A, said corner also being the point of beginning; thence S 48°-13'-39" W along the Southeast line of Indian Claim 164 a distance of 728.14 feet to the Southeast corner of Indian Claim 164 and also marking the common corner for Indian Claim 164, Indian Claim 160 and Indian Claim 159; thence S 58°-18'-33" E along the Northeast line of Indian Claim 159 a distance of 40.87 feet to the West line of Volume 667, Page 53 of Records; thence S 29°-33'-40" W along said West line of Volume 667, Page 53 of Records a distance of 543.57 feet to a previous monumented and surveyed line for the South line of the Southwest One-quarter of Section 35 and the North line of Volume 1118, Page 631 of Records; thence N 89°-52'-48" W along the previous monumented and surveyed line for the said South line of the Southwest One-quarter of Section 35 and the North line of Volume 1118, Page 631 of Records a distance of 283.97 feet to an existing Brown County Monument marking the Southeast corner of Section 35; Thence S 89°-52'-13" W along the South line of the Southeast One-quarter of Section 34 and the North line of Volume 1118, Page 631 of Records a distance of 131.88 feet to an existing and previously surveyed 1" pipe marking the Northwest corner of Volume 1118, Page 631 of Records and being on the Northeast line of Indian Claim 156; thence S 55°-35'-29" E along the said Northeast line of Indian Claim 156 a distance of 481.73 feet to an existing Brown County Monument marking the Easterly most corner of Indian Claim 156 and also marking the common corner of Indian Claim 156, Indian Claim 157 and Indian Claim 159; thence S 55°-55'-39" W along the Southeast line of Indian Claim 156 a distance of 1009.57 feet to an existing Brown County Monument marking the Southerly most corner of Indian Claim 156; thence N 70°-25'-42" W along the Southwest line of Indian Claim 156 a distance of 960.55 feet to the Southeast right-of-way line of State Trunk Highway "54"; thence N 28°-35'-01" E along said Southeast right-of-way line of State Trunk Highway "54" a distance of 1040.53 feet; thence N 34°-11'-22" E along said Southeast right-of-way line of State Trunk Highway "54" a distance of 1658.51 feet to the Northeast line of Indian Claim 164; thence S 54°-27'-14" E along said Northeast line of Indian Claim 164 a distance of 1359.75 feet to the point of beginning.
