- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as:
Former POJO Enterprises Property
- WHEREAS, the parcel is described as follows:
Legal Description: See attached.
Tax Parcel Number: 6H-1633
- WHEREAS, the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide an existing residential housing land use and will not be used for gaming purposes, and
- WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement,
- NOW THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.

That part of Lot Thirteen (13), according to the recorded Plat of Packerland Subdivision, and that part of vacated Canadeo Court, in Section 28, Township 24 North, Range 20 East of the Fourth Principal Meridian, in the City of Green Bay, West side of Fox River, Brown County, Wisconsin, more fully described as follows:

Beginning at the Southwest corner of Lot 13 of the recorded Plat of Packerland Subdivision; thence North $02^{\circ} 40' 35''$ East, 351.40 feet along the Easterly right of way of U.S.H. "41"; thence North $08^{\circ} 33' 35''$ East, 338.01 feet along said Easterly right of way ; thence North $89^{\circ} 58' 35''$ East, 242.22 feet along the Southerly right of way of Larsen Road; thence 21.11 feet along the Southerly right of way being the arc of a 264.99 foot radius curve to the right whose long chord bears South $87^{\circ} 44' 28.5''$ East, 21.11 feet; thence South $02^{\circ} 34' 19''$ West, 693.07 feet; thence North $88^{\circ} 07' 00''$ West, 298.79 feet along the South line of said Lot 13 to the point of beginning.
