Oneidas bringing several hundred bags of corn to Washington's starving army at Valley Forge, after the colonists had consistently refused to aid them.

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Former Keith R. Selissen and Roxanne G. Selissen Property

WHEREAS, the parcel is described as follows: Legal Description: See attached. Tax Parcel Numbers: 6H-3261

WHEREAS, the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide an existing residential housing land use and will not be used for gaming purposes, and
