## *Correction of 8-16-06 N Fee to Trust Resolution for Former Daren L. Krueger Property and Approval of Resolution and Warranty Deed*

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin has acquired in fee status the following parcel described as: Former Daren L. Krueger Property
- WHEREAS,** the parcel is described as follows:  
Legal Description: See attached.  
Tax Parcel Numbers: 6H-767-7
- WHEREAS,** the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide an existing residential housing land use and will not be used for gaming purposes, and
- WHEREAS,** the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and
- WHEREAS,** prior Resolution BC 8-16-06-N cited incorrect tax parcel number,
- NOW THEREFORE, BE IT RESOLVED,** that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.
- NOW THEREFORE, BE IT RESOLVED,** that the Oneida Business Committee Resolution 8-16-06-N is repealed.

That part of the West One-half of the Northeast One-quarter of the Southeast One-quarter ( $W\frac{1}{2}$  of  $NE\frac{1}{4}$  of  $SE\frac{1}{4}$ ) and that part of the Southeast One-quarter of the Southeast One-quarter ( $SE\frac{1}{4}$  of  $SE\frac{1}{4}$ ) of Section Twenty-five (25), Township Twenty-four (24) North, Range Nineteen (19) East of the Fourth Principal Meridian, in the City of Green Bay, West side of Fox River, Brown County, Wisconsin, described as follows:

Commencing at an iron stake in the South line of STH 54, 37.9 feet Northeast of the point where the West line of the  $SE\frac{1}{4}$  -  $SE\frac{1}{4}$  of said Section 25, T24N, R19E, intersects the South line of STH 54; thence South and parallel with the said West line 87.9 feet; thence East at right angles 466.7 feet to the place of beginning of the property to be herein described; thence North at right angles 447.75 feet to the South line of STH 54; thence  $N 51^{\circ} 51' E$  185.35 feet; thence  $S 0^{\circ} 24' E$  462.2 feet; thence East at right angles 10.00 feet; thence  $S 0^{\circ} 24' E$  98.7 feet; thence West at right angles 160.00 feet to the place of beginning, as described in Volume 303 Deeds 675, Brown County Records.
