
### Resolution # 5-29-02-A APPLICATION FOR OFFICIAL STATUS AS A TRIBAL HISTORIC PRESERVATION OFFICE

- WHEREAS,** the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS,** the General Tribal Council has been delegated the authority of the Constitution of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS,** the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council; and
- WHEREAS,** the National Historic Preservation Act Section 101 (d) provides "A tribe may assume all or any part of the functions of a State Historic Preservation Officer in accordance with subsections (b)(2) and (b)(3) with respect to tribal lands;" and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin began historic preservation planning in 1991 through OBC Resolution #03-01-91-B; and
- WHEREAS,** the Oneida Cultural Heritage Department was delegated to design and implement the Oneida Historic Preservation plan in 1995; and
- WHEREAS,** the Oneida Business Committee adopted the "Ordinance for the Protection and Management of Archeological, Cultural, and Historic Resources" by OBC Resolution # 06-10-98-A; and
- WHEREAS,** all requirements to become an official Tribal Historic Preservation Office ("THPO") have been completed, and the Oneida Nation is ready to assume all the THPO responsibilities, except for reviewing applications to restore historic buildings.

**NOW THEREFORE BE IT RESOLVED,** the Oneida Business Committee approves the application to the National Park Service for official status as a Tribal Historic Preservation Office.
