
Oneida Nation School System Grant Application to Office of Indian Education Programs - Title VII

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Tribe has determined as part of its Seventh Generation Commitment, "To develop a provisional system that fits our "family"/community values such as food, shelter, clothing and education as well as other services," and
- WHEREAS,** the Oneida Tribe has established the Oneida Nation School System for its most cherished responsibility—education of our children—to renew and revitalize the dignity of and harmony amongst Oneida People, in accordance with Oneida's need for cultural survival and well-being, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin continues to supports the Oneida Nation School System five year plan which follows the new Public Law 107-110, No Child Left Behind legislation, and;

NOW, THEREFORE, BE IT RESOLVED, that the Oneida Tribe of Indians of Wisconsin submits a grant application to the Office of Indian Education 2003 Title VII grant program for the purposes of assisting Native American students to achieve the same challenging standards expected of all students by supporting access to programs that meet their unique educational and culturally related academic needs.
