
### Oneida Food Distribution Program/Oneida Pantry Emergency Network (O.P.E.N.)/United Way/Gifts-In-Kind International

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the governmental body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the goal of the Oneida Tribe is to protect, maintain, and promote self-sufficiency and self reliance by providing food and support services for Oneida Tribal members and others in the community who cannot afford it, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin has established the Oneida Food Distribution Program and the Oneida Pantry/Emergency Network (O.P.E.N.) to provide food for low and very low-income families that need food, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin through the Oneida Food Distribution Program and the Oneida Pantry/Emergency Network (O.P.E.N.) provides a community-based food distribution service network, and
- WHEREAS,** the Oneida Tribe believes that the Oneida Family will be strengthened by promoting the overall health and well ness of all Oneida community members, especially those who cannot afford food.

**NOW, THEREFORE, BE IT RESOLVED:** That the Oneida Tribe of Indians of Wisconsin-Oneida Food Distribution Program and the Oneida Pantry/Emergency Network (OPEN) authorizes and submits this grant application to the United Way/Gifts-In-Kind International for the purpose of securing computer technology to support the efforts of providing food for those who cannot afford food.
