Oneida people live, and

WHEREAS, the Oneida Tribe has established the Oneida Environmental Health and Safety Department to

WHEREAS. the Oneida Tribe hereby requests financial assistance under s. 159.23, Wis. Stats., and Chapter NR

542, Wis. Adm. Code, for the purpose of planning constructing or operating a recycling program

with one or more components specified in s. 159.11(2)(a) to (h), Wis. Stats.,

Stats. And Chapter NR, Wis. Adm. Code; sign necessary documents, and submit a final report.
