WHEREAS, the Oneida Nation of Wisconsin is a federally recognized Indian government and a treaty tribe

recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Nation of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section of the

Oneida Tribe Constitution by the Oneida General Council, and

WHEREAS, Congress by enactment of the Transportation Equity Act of the 21st Century (TEA21) provided a

mechanism for Indian Tribes to exercise the right to SELF-DETERMINATION, and

WHEREAS, the Transportation Equity Act for the 21ST Century (TEA-21), has provided funding to the Bureau

of Indian Affairs for the purpose of Transportation Planning on Oneida Nation Land.

WHEREAS, the Oneida Nation granted a right-of-way to the Bureau of Indian Affairs for County Highway "H"

and Ranch Road located on the Oneida Nation Reservation and authorizes its Chairwoman and Secretary to negotiate for the grading and surfacing of the same by virtue of Resolution 1-17-02,

and

NOW THEREFORE BE IT RESOLVED: that the Bureau of Indian Affairs, under Public Law 93-638, has offered to the Oneida Nation Contract No. CTF55T43349 for \$252,965.00 for the purpose of County Highway "H" and Ranch Road grading and bituminous surfacing.

NOW THEREFORE BE IT FURTHER RESOLVED: That the Oneida Nation hereby authorizes its Chairwoman, Cristina Danforth, and the Tribal Secretary, Julie Barton, to sign Contract CTF55T43349 for the above stated purpose.
