Oneidas bringing several hundred bags of corn to Washington's starving army at Valley Forge, after the colonists had consistently refused to aid them.

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governmental body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the goal of the Oneida Tribe is to protect, maintain, and promote self-sufficiency and self reliance by providing food and support services for Oneida Tribal members and others in the community who cannot afford it, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin has established the Oneida Food Distribution Program-Oneida Pantry/Emergency Network (OPEN) to provide food for low and very low-income families that need food but do not qualify for other food programs, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin through the Oneida Food Distribution Program-Oneida Pantry/Emergency Network (OPEN) would like to expand and support a community-based food distribution service network and create a self-sustaining Oneida Pantry/Emergency Network, and

WHEREAS, the Oneida Tribe believes that the Oneida Family will be strengthened by promoting the overall health and well ness of all Oneida community members, especially those who cannot afford food.

NOW, THEREFORE, BE IT RESOLVED: That the Oneida Tribe of Indians of Wisconsin-Oneida Food Distribution Program-Oneida Pantry/Emergency Network (OPEN) authorizes and submits this grant application to the First Nations Institute/Native American Hunger Program (NAHP) for the purpose of securing funds to support the efforts of providing food for those who cannot afford food.
